1. STUDENT AND EMPLOYEE ACHIEVEMENTS

Rick Stock happily reports that the ORL Program has received a grant for \$24,000 for the purchase of equipment used to teach FRC boating safety curriculum. It will be used to purchase rafts, kayaks, stand up paddle boards, and supporting gear.

California State Parks have asked the ORL Program to assist them with the production of a safe whitewater boating



video. Production crews will be on hand to videotape rafts and kayaks on the river. Additionally, FRC students will be the actors who read the script. The final product will appear on the California State Parks website.



With help from **Alyia Pilgrim**, this semester was the first time that FRC used the Burton Book Fund, a textbook assistance program through the John Burton Foundation for foster youth. FRC successfully awarded over \$2,000 to help foster youth purchase textbooks. This additional resource is now available on campus for qualified students.

Sarah Ritchie and the Sand Volleyball team are off to a great start of the season. Nina Holmes and Morgan Hughes won the gold bracket at the Coast Conference Beach Kickoff out of 30 doubles team. Ariana Cortez and Stacey Witt won the Silver bracket for FRC as well.


Governor Jerry Brown's Civil Service Improvements (CSI) initiative was created as a means to "ensure the state has a strong and nimble civil service system." The CSI Project 5.7C was commissioned to identify and recommend the State of California's adoption of a foundational set of competencies, or core skills, that would apply to all of the state's workforce both existing and incoming. Through the CSI project, the New World of Work 21st Century Skills curriculum was reviewed and determined to be a model of reference as CalHR creates the new state foundational guidelines for competencies. This is another kudos in the long line of accomplishments of Rajinder Gill and her leadership of this effort.

Pamela Crespin has been busy as Director of the Adult Education Grant. The preliminary allotment schedule for the California Adult Education Grant Program (AB 104), which was released last week, shows the Feather River Consortium is scheduled to receive \$773,016 in 2016-17. The American Astronomical Society has featured an <u>article on</u> their website about the RECON project which includes, among other things, a light-curve from one of our occultation observations at Feather River College. Charley Arrowsmith reports the complete <u>original paper by Marc Buie and John Keller</u> was published in The Astronomical Journal.





In addition to Charley, the RECON teams in Plumas County include science teachers at Quincy High School, Plumas Charter School in Greenville, and Portola High School, as well as other community members including current FRC student Will Anderson. These teams were all part of the original RECON pilot project involving citizen-scientists in a dozen communities. The full RECON project now includes teams in 56 communities stretching from the Canadian to the Mexican border.

3. THE FUTURE OF ACCREDITATION AT CALIFORNIA COMMUNITY COLLEGES

On Monday, March 21st the Board of Governors will be asked to consider the recommendations from the Chancellor's Office Accreditation Task Force, which includes, among other items, to explore alternate regional accrediting bodies instead of relying on ACCJC. Recent legislation has been presented to allow California community colleges to utilize a different accrediting body. It is important to note that each college is a member-college and it is the college's decision to be accredited by any entity – albeit the legislature language currently requires all CCC's to be under the same entity of ACCJC.

At the recent California Community College CEO Symposium, there was a very detailed and informative discussion by college presidents about the Task Force recommendations, recommendations from the CEO board, and other options for the future of community college accreditation in California, Hawaii and the Pacific Islands. Part of this discussion involved the movement of community colleges to offer limited bachelor's degrees and part of this discussion included the expansion into Adult Education through AB 86 and high school concurrent enrollment options.

The results of the Board of Governors meeting might dictate the future direction for our state system. Time will tell where these decisions will lead FRC and other colleges. Regardless, the pledge is to insist upon a peer evaluation process that is free from legislative and political influence for accreditation decisions. Whether a new model and a new accreditor is utilized, or if we remain under ACCJC, it is important to note that such transitions may take several years to a decade. Be on the lookout for a press release early next week about the Board of Governors decision as the first step in this undetermined process.

4. APRIL IS SUSTAINABILITY MONTH AT FRC

Last year, the Board of Trustees passed a resolution establishing April as Sustainability Month at FRC. The purpose is to:

<u>Remind</u> all students, faculty, staff, and administrators that April is the month when Earth Day is celebrated,

<u>Note</u> that April 22, 2016 is the 47th Earth Day, which was founded by Senator Gaylord Nelson in 1970 to raise awareness about the state of the environment,

Stress the value of each individual striving to reduce one's ecological footprint,

- 1. <u>Challenge</u> everyone to take a small step such as:
 - · chair a paperless meeting
 - carpool once a week
 - eat an all-California sourced meal
 - participate in the Earth Week trash pick-up contest,
- 2. <u>Encourage</u> our campus community to acknowledge the importance of spending time outdoors in natural settings as a way to sustain body, mind, and spirit.

5. PTK News

There are 85 members of FRC's Alpha Psi Zeta chapter as of March 10, 2016.

Alpha Psi Zeta Vice President **Will Anderson** has been named a semifinalist for the Jack Kent Cooke Foundation Undergraduate Transfer Scholarship. This year the Cooke Foundation received over 2,300 applications from students across the country, from which 85 will be chosen. Being a semi-finalist is a significant achievement and we are keeping our fingers crossed for Will!

Alpha Psi Zeta is proud to announce its first ever transfer scholarship. Due to generous contributions of faculty, administrators, alumni, and community members, this year a graduating PTK member who will be enrolled in a higher degree program in Fall 2016 may apply for this \$1,000 award. Payment Notice Process for Past Due Accounts

- Students who owe past due fees of any kind (enrollment, housing, library, parking) have a hold on their account and are not allowed to enroll in subsequent semesters or request official transcripts.
- Due to Ed Code regulations, students cannot be dropped from classes due to nonpayment once the semester has started.
