**SPECIAL NEVADA (GOOD NEIGHBOR)
STUDENT ADMISSION PROGRAM**

Feather River Community College District can admit full-time students who are Nevada residents at a reduced non-resident tuition rate until November 29, 2011. Eligible students are those who have lived in Nevada continuously for the previous 12-month period.

Students who apply and are granted this special tuition rate will pay \$42 per unit tuition (plus health, parking and transit fees) rather than the tuition for out-of-state students (\$199 per unit plus enrollment fees).

Eligibility for consideration as a *Good Neighbor Student* requires the following:

1. Completed Good Neighbor application with supporting documentation submitted to the Admissions & Records Office no later than November 29, 2011

AND

2. Enrolled as a full-time student (12 units) by November 29, 2011 for the Spring 2012 term.

Good Neighbor applications may be submitted November 18-29, 2011. Copies of documents to verify Nevada residency must be submitted with applications to be considered and processed. Incomplete applications will not be considered for the Good Neighbor tuition rate and nonresident out-of-state rates (\$199 per unit plus enrollment fees) will be assessed to the student's account. Students previously granted Good Neighbor status would retain their reduced nonresident tuition rates as long as they remain continuously enrolled until they complete their educational program or until which time the Good Neighbor program is terminated.
