SPECIAL NEVADA STUDENT ADMISSION PROGRAM

Feather River Community College District will be admitting full-time students who are Nevada residents at a reduced nonresident tuition rate. Eligible students are those who have lived in Nevada continuously for the previous 12-month period.

Students will pay \$42 per unit tuition (plus health, parking and transit fees) rather than the tuition for out of state students (\$182 per unit, plus enrollment fees). Eligible Nevada students may enroll in summer session with less than a full-time equivalent load and receive the reduced tuition fee.

Feather River College reserves the right to limit the number of Special Nevada Students based on a first come, first served basis.

To be considered as a *Special Nevada Student* complete the application form (see reverse), and attach copies of documents that verify Nevada residency.

Please complete the form in its entirety. You may submit the form before or at the time of enrollment and must provide copies of documents to verify residency in order for your application to be processed.
