High School Co-Enrollment Student Permit 2009-2010

Registration Process: Plumas County High School students are eligible to be co-enrolled at Feather River College for up to nine units of credit. Fees for the units taken will be waived by FRC *with the exception of* health fees (\$17) and transit fees (\$1.50 per unit).

Example:

6 units x \$26	= \$156 (waived)
Health Fee	= \$17 for Fall \$14 for Summer
Transit Fee (6 x \$1.50)	= \$9
Student pays total	\$26 Fall \$23 Summer

Registration Dates:

April 27, 2009 for
Fall and Summer Semester

November 16, 2009 for
Spring Semester

An additional cost to consider is a parking permit which is required if you will be parking on campus for day or evening classes. Parking permits are \$20 per semester. Keep in mind that by paying the transit fee students are eligible for a bus permit for the Plumas Transit. Parking permits and bus passes are available in the Admissions and Records Office.

The following is required for all high school students enrolling at Feather River College:

1. Complete the enrollment form and obtain the required signatures outlined on the form.
2. New students must complete an Application for Admission online at www.frc.edu and then "Click to Apply Now."
3. Assessment testing is required for all academic classes. Please contact the Assessment Test Coordinator at 283-0202, extension 313, to schedule an assessment test and an appointment to meet with an advisor/counselor for class selection and signature. For non-academic courses such as P.E., Theatre, etc., assessment may be waived.
4. Due to higher education rules concerning confidentiality of college students, registration for courses is to be conducted personally by the student not by a proxy.
5. Pay appropriate fees in the Admissions & Records Office.

Feather River College cannot provide remedial courses to high school students who have not passed the High School Proficiency Examination and are under the age of 18. This program is designed for students prepared to go beyond high school level coursework.

Once registered, students will be issued an FRC identification number and may view their schedule, account statements, and final grades on the Student Self Service portal on the FRC website. All students are eligible for two free official transcripts and subsequent transcripts are \$5.00 each. Transcripts may be requested in the Admissions & Records Office.
